Players are strongly advised to get their own private health or travel insurance in case their medical expenses are not covered by the \$2,000. The policy will pay on 75% of your medical expenses up to a total of \$2,000. The policy does not pay on loss of income from time off work as a result of injury. Management of all Insurance Claims are the responsibility of the individual player/club and not the GAAWA. Clubs need to contact the Insurance Brokers, Local Government Insurance Services (LGIS).
